**SEALED TENDER NOTICE**

Sealed Tenders are hereby invited as per the schedule annexed to this notice on behalf of the Chairman, Mizoram State Health Society from reputed and bonafide Manufacturers or their only authorized dealers, for **'Open Tender for Supply of Merchandise (T-Shirt) for HWA & HWM under School Health & Wellness programme(Ayushman Bharat)'** which will be received by the Mission Director, NHM, H & FW Department, Dinthar, Aizawl, Mizoram on or before **6<sup>th</sup> March 2026** up to **12:00 Noon**. Tenders are to be opened by the Technical Committee under the chairmanship of Mission Director, NHM, Mizoram, Aizawl or his authorized representatives at **1.00 PM** on the same day. The Tenderers or their representatives may also be present at the time of opening of the Quotations, if they so desire.

**TERMS AND CONDITIONS**

1. The cover of the tenders should be superscribed as **'Open Tender for Supply of Merchandise for HWA & HWM under School Health & Wellness Programme (Ayushman Bharat)'** addressed to the Mission Director, National Health Mission, Dinthar, Aizawl clearly indicating full postal address of the tenderer.
2. Tenders shall be submitted in the prescribed form only which can be obtained from the office of Mission Director, National Health Mission, Dinthar, Aizawl, Mizoram on working days.
3. Tenders shall be accompanied with the Earnest Money Deposit of **Rs 28,000/-** which is 2% of approval in the form of Demand Draft/Deposit at Call in original, from any Nationalized Bank of India or Postal Saving Certificate duly pledged in favor of Mission Director, National Health Mission, Mizoram, Aizawl.
4. Manufacturers submitting their tenders directly shall attach photo copies of their Manufacturing Licence, PAN Card, and other relevant permissions/licences required for such manufacturing duly attested by a Gazetted Officer or Notary. Original Certificates shall be produced at the time of opening of the tenders/quotations, if demanded.
5. Tenders received from firms and individuals who are not authorized dealers but only authorized to quote on behalf of the manufacturer or dealer shall be accepted. Authorized dealers shall attach Authorization or Distributorship or Dealership, as the case may be from the concerned Manufacturers. A Gazetted Officer or Notary, however, shall duly attest such photo copies. Original Certificate shall be produced at the time of opening of the tenders/quotations,if demanded.
6. Quoted rates in terms of Indian Rupees shall be considered inclusive of all Taxes. If there are more than one brand, the separate rates for such brands with specific details should be mentioned.

7. FOR destination, '**State Nodal Officer, (RBSK/RKSK), School Health Section, DHS, MINECO, Khatla, Aizawl, Mizoram**' shall be clearly mentioned in the quotation. Transportation/shipping charge will be borne by the successful bidder.
8. Soft copy of tender document shall be enclosed alongwith other documents.
9. Tender must be accompanied by the following documents-
  - a) Photo copy of Scheduled Tribe Certificate duly attested by a Gazetted Officer or Notary (for Tribal tenderer). Original Certificates should be produced at the time of opening of the tenders/quotations,if demanded.
  - b) Non-Judicial Adhesive Stamp worth at least Rs.7.50 should be affixed (for non-tribal tenderer)
10. All pages of the tender papers should be printed, signed, stamped and dated; hand written quotations shall not be entertained. Any page or pages not signed, stamped or dated will be marked violated clause at the time of opening of tender.
11. Samples may be submitted in a separate box/packet marked as SAMPLE clearly indicating Tender no. and date with Bidder's complete address.
12. A successful tenderer has to execute an appropriate Deed of Agreement within 15 (fifteen) days from the date of communication of acceptance of his/her quoted rate(s), failing which the tender will become invalid.
13. If any tenderer violates or fails to fulfill any one of the clauses, his or her tender is liable to be rejected at the time of opening the tender or meeting of Purchase Committee, MSHS.
14. Once the rate is accepted and communicated to the successful firm, the same will remain valid during the supply period of the agreement with the approved supplier and no price escalation will be permissible during the valid period, which is normally for a period of 12 months and is extendable, if mutually agreed upon by both the parties i.e. State Health Mission and concerned approved supplier, subject to the recommendation of the Purchase Committee, Mizoram State Health Society, as the case may be.
15. A successful tenderer whose tender has been accepted shall furnish Security Deposit of 5% (five percent) of the value of the materials required to be supplied, at the time of execution of the agreement, in the form of Demand Draft/Fixed Deposited in any Nationalized Bank of India or Postal Savings Certificate, as the case may be, duly pledged in favor of Mission Director, NHM, Government of Mizoram, Aizawl.
16. A successful tenderer shall supply the items within the stipulated time. If the supply cannot be completed within the stipulated period without any valid and justifiable reasons or prior intimation, the Society shall be at liberty to procure the materials from the next lowest tenderer and the

differences in prices, if any will be realized from the Security Deposit of the successful and approved tenderer without assigning any reason thereof.

17. The Society shall not be bound to accept bids submitted by previous supplier who had a history of defaulting from agreement clauses or who had failed to comply with supply period/terms. Hence, the Society reserves the right to accept or reject any tender, even if valid, without assigning any reason thereof/based on previous performance.
18. All payments will be made only after the materials are received in full and in good condition and after satisfactory completion of supply.
19. If the above items are violated or unfulfilled, tender shall be rejected at the time of opening of the tender.
